4. Treasurer's Report – Stacey Heins

a. Budget

The Treasurer outlined options for fee increases to cover increasing ice and referee costs. After considerable discussion and questions about the impacts of options for house and rep players, it was decided to defer a decision on the fees until after additional information about historical increases and the budget was provided to members.

It was emphasized that a decision would be required in a timely manner as registration normally opens on July 1st and fees must be determined before registration can open.

b. Repayment of advance and repercussions of late payment

The Treasurer explained there was a situation where a Rep B coach had received an advance from the Association in order to offset the costs of registering for tournaments, but had not repaid the advance despite repeated efforts.
