

# MDHA Executive Meeting Tuesday February 18th, 2025 7:00 pm via Webex

#### Call to Order

The President called the meeting to order at 7:03 pm. She noted the lack of quorum and indicated votes will be deferred until the next meeting.

## **President's Report**

a) Presidents' meeting

The President provided a debrief of the GHA Presidents Meeting that took place on February 8<sup>th</sup>, 2025:

- There was a discussion about younger officials.
- The GHA will be holding a coaches-managers meeting next season with the Referee-in-Chief and the Discipline Chair. There may be a separate GHA meeting to be determined.
- There is a change to game switch policy at this point of the season and a mass update will be coming from GHA.
- An email on playing with AAA/AA/A teams after playing with an unsanctioned league has been distributed.
- News on spring tryouts will be coming shortly. AAA ends April 27<sup>th</sup>.
   Rangers will be May 3-20.
- House League playoff rules were approved. The VP House was asked to make sure that a copy of the rules is posted in the timekeepers box and

convenors need to send to coaches. The rules will also be posted on the GHA website.

 The 5 Presidents will be meeting in the weeks ahead to discuss the way ahead for Rep B in light of declining enrolment numbers and the need for greater competitive balance.

#### b) AGM prep

The President noted that the Annual General Meeting is approaching. Board members were advised to prepare if there is anything they want to raise. The AGM will be in May and scheduled after we know the GHA AGM date.

The President also enforced email etiquette and asked that the whole Executive not be copied on all emails if not required.

She also wished teams well in the playoffs.

The Past President reminded Executive members she is the Chair of the Nominating Committee and will be reaching out to Executive members to see if they would like to return to the Board next year. She already knows that the Ice Scheduler position will be vacant.

The Past President reported that the graduating player game has been scheduled for March 16<sup>th</sup>. She has identified two captains and two coaches and needs to assemble teams. The VP House was working on finding officials. She will be looking for photos from parents to post on social media.

#### 3. Treasurer's Report – Rebecca

The Treasurer reported that the bank balance was around \$122K. She had completed the team budget reviews. Her written report was distributed and is attached.
